

# **MI City Income Tax**

#### • Who must file:

- Persons who owe tax or are due a refund
- Residents whose AGI exceeds the personal exemption for that city
- Non- / Part-year residents whose city wages exceed the personal exemption
- Residents who file a Federal return (even if no city tax is owed) should file

## MI City Income Tax – CF-1040

- 22 MI Cities have local income taxes: many accept Common Form 1040 (CF-1040)
- Includes Pontiac, Highland Park, Hamtramck (Do not use for Detroit or Port Huron)
- Return must be paper filed print two copies

## MI City Income Tax – CF-1040

- Special Exemptions vary by city
- Exclusions/Adjustments may vary by city


# MI City Income Tax – CF-1040

- You may be able to start a CF-1040 in TS, print it and complete by hand


# **MI City Income Tax**

  - Column A = Federal 1040


#### plus/minus

- Less: Exemptions


#### equals

- Column C = Taxable Income


# Sample CF-1040 Format







Once you've passed this step, the only way to change residency is to delete the entire STATE return and start over



## **MI Cities Income Tax - TaxSlayer**

- Use the city tax instructions as a guide
- Note differences in exemptions, exclusions, adjustments depending on city
- Note differences depending on residency status
- Begin input in TaxSlayer of data for CF-1040



## Mi Cities CF-1040

- "Continue" back out through the input screens until the Fed & MI tax due/refund amount recalculates to ensure data is saved
- Review preliminary CF-1040 from the print pdf
- Confirm all adjustments/exclusions follow specific city rules
- Make any corrections needed may require "finessing" TaxSlayer input

### **MI Cities CF-1040**

- In complicated cases, or when TaxSlayer input is confusing or uncooperative:
- It may be easier to complete a tax return manually for the client (using the beginning of the CF-1040 or the city form)
- Remember: the client must paper file the form either way

### **MI Cities CF-1040**

- If you are completing a paper return (manually or using a fillable pdf), be extremely careful during the Quality Review
- All arithmetic must be done manually and checked carefully
- Can be very time consuming

#### **MI Cities Paper Return**

- When filing a paper return
  - Print two copies for client one to mail
    & one for their file
- Print extra copy of Federal forms that must be attached to the return
  - Federal 1040 Page 1 & Schedules B, C, D, E
  - Other city return (credit for taxes paid to other city)
  - Taxpayer should attach W-2's & 1099-R's (if taxable)

#### **MI Cities Paper Return**

- Instruct the client that they must sign and mail in the return with their payment (if owed)
- Give them the extra copies of Federal forms to attach
- Explain what other forms they should attach (usually shown on front of city return in the left margin)
